1. General provisions

1. This Kazakh Language Policy (hereinafter referred to as 'KLP') is for the autonomous organization of education Nazarbayev University (hereinafter – NU) undergraduate programs.

This KLP sets minimum standards for Kazakh courses indicated in NU Undergraduate Core Curriculum requirements.

2. Kazakh language courses

- 2. Kazakh courses are courses taught by the Department of Kazakh Language and Turkic Studies of the School of Humanities and Social Sciences (hereinafter -Kazakh Department), with the course code designator, KAZ or KFL.
 - 3. For purposes of this Policy:
 - 1) Advanced Kazakh courses are KAZ courses at the 300 or 400-level.

3. Kazakh Language Policy requirements for students beginning at NU in 2019-2020 and after

Requirements for Graduation:

1) For students graduating with a non-B.A. degree

Students who, when they enter NU, are placed at the C1 level according to Common European Framework of Reference for Languages (hereinafter – CEF), are required to complete two KAZ courses at the 'Advanced' level.

Students who have graduated from high schools in the Republic of Kazakhstan and enter NU with A or B language level, are required to complete two KAZ courses, including KAZ 202 Academic Kazakh II.

Students who are graduates of high schools outside of Kazakhstan and enter NU with A or B language level, are required to complete two courses, including KAZ



201 Academic Kazakh I.

Students who have no ability in Kazakh when they enter NU are required to complete KFL 201 Intermediate Kazakh as a Foreign Language I.

2) For students graduating with a B.A. degree:

Students who, when they enter NU, are placed at the C1 level according to CEF, are required to complete two KAZ courses at the 'Advanced' level.

Students who have graduated from high schools in the Republic of Kazakhstan and enter NU with A or B language level, are required to complete KAZ 202 Academic Kazakh II and one KAZ course at the 'Advanced' level.

Students who are graduates of high schools outside of Kazakhstan and enter NU with A or B language level, are required to complete two courses, including KAZ 202 Academic Kazakh II.

Students who have no ability in Kazakh when they enter NU are required to complete KFL 202 Intermediate Kazakh as a Foreign Language II.
